Disposal of a Ferry Craft "M.L. Harachandi" stationed at Magarmukh, Satapada, District: Puri.

- i) Make, Model and Type:-Ferry Craft – 2001-02
- ii) Year of purchase: - 2001-02
1. The intending tenderers are advised to inspect the Ferry Craft kept in the premises of Chilika Development Authority, Magarmukh Satpada, Puri on any of the working days preceding the last date of submission of tender. The tender should accompany an earnest money deposit of Rs.2,00,000.00 (Rupees two lakhs) only in shape of Bank Draft drawn in favour of Chief Executive, Chilika Development Authority and payable at Bhubaneswar. This will be refunded back to the unsuccessful bidders.
 2. The tender should reach the undersigned by dt.15.01.2018 by 3.00 P.M. and will be opened on the same day at 4.00 P.M. in presence of the tenderers or their authorized agents.
 3. The highest tenderer whose tender will be accepted shall have to deposit 25% of the offered amount on the spot after the sale is confirmed and the rest amount within 7 (seven) days from the date of confirmation of the tender. The successful tenderer shall remove the ferry craft from the premises of the office of the Chilika Development Authority within seven days from the date of depositing the full amount of the tendered money. In case he fails to deposit of the total amount as per the tender within the stipulated time, the deposits including earnest money shall be forfeited.

On failure to remove the ferry craft within the aforesaid time, the ground rent @ 1% of the tendered amount shall be charged per each day or part of the day till removal of the ferry craft from the site. If the ground rent so charged exceeds the sale price deposited, the tenderer shall cease to have any right on the ferry craft and the amount deposited by him shall be adjusted towards ground rent.

The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
