1. The Quotations must be accompanied with EMD @ 1% of the total value of the requirements at the respective quoted rates in shape of Postal Term deposit or Deposit of any Nationalised Scheduled bank in the State duly pledged in favour of Chief Executive, Chilika Development Authority, Bhubaneswar.
2. The valid copies of PAN, GST Registration certificate should be submitted along with the quotation.
3. The participants have to submit the documentary evidence in support of their registration / manufacturer status etc. along with the quotation.
4. Experience in the similar and identical work if any may be submitted with supporting work order copies or performance certificates.
5. The documents submitted along with the quotation will be verified with the originals at the time of opening of quotations.
6. The Quotation should contain the price quotations clearly mentioning the rates per unit in figure and words in neat. In case of any variations between the rates in figures and the words, the rates in words will be taken into consideration.
7. The validity period of the quotation should be 45 (forty five) days from the date of submission of quotations.
8. The quotations not accompanied with EMD as specified above, copies of GST Registration Certificate & PAN will be summararily rejected.
9. Non completion of the supply within the stipulated period will carry penalty @0.5% of the value of the purchase order not executed per day subject to maximum 10% of the value of the purchase order towards delay. Exceeding that the purchase order stands cancelled automatically and the EMD will be forfeited and taken into Government account. If there is genuine reasons for delay, the same should be brought to notice of the Chief Executive, Chilika Development Authority immediately on occurrence for

allowing the reasonable time with or without fine by competent authority after due verification to the facts.
